• Issue an Air Operator Certificate (AOC) or equivalent document which shall be dependent upon the operator demonstrating an adequate organization, method of control and supervision of flight operations, training program, and maintenance arrangements consistent with the nature and extent of the operation specified (para. 4.2.1.3);

An Air Operator's Certificate (AOC) is an authorisation granted by CASA under the section 27 of the Civil Aviation Act to conduct commercial activities prescribed by regulation 206 of the Civil Aviation Regulations 1988 (CAR). All AOCs are issued for a specified term.

An air operator's certificate (AOC) is the approval granted by a national aviation authority (NAA) to an aircraft operator to allow it to use aircraft for commercial purposes. This requires the operator to have personnel, assets and system in place to ensure the safety of its employees and the general public.

Foreign air carriers or operators who would like to conduct passenger or cargo operations to, from, and transiting the United States, must obtain a permit issued by the Department of Transportation (DOT) under Title 49 of the United States Code (49 U.S.C.).

Foreign air carriers (Part 129)

The duties and responsibilities of Flight Operations Inspectors are laid down in the Flight Operations Inspectors Manual and are divided into Surveillance, Operational Inspections that could lead to Certification of an Operator and the subsequent issue of an Air Operator Certificate by the Director General, and Airman Certification.
