An example of items that are exempt from Texas sales tax are items specifically purchased for resale. This means that an individual in the state of Texas purchases school supplies and books for their children would be required to pay sales tax, but an

2.1 Exclusive Sales Agency. In accordance with this Section 2, MPS shall act as Partnership's exclusive sales
